Polytechnic, Dhenkanal, the First Party will sponsor students in groups in consultation with the 2nd party at least twice in a year for the exposure visit and the Second Party will allow and impart the exposure training for enhancing employability in the job market.

(H)Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest;

That

CLAUSE 1: COOPERATION

Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

CLAUSE 2: SCOPE OF THE MOU

- 2.1 The Second Party shall act as the Field Knowledge Provider to the student engineers to have on the site exposure to different field and quality control tests undertaken during project report preparation, execution and monitoring.
- 2.2 **Skill Development Programs:** Second Party agrees to train the students of First Party on the emerging technologies in order to bridge the skill gap and make them industry ready.
- 2.3 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the programs on the terms specified herein.
- 2.4 **Govt. Polytechnic, Dhenkanal,** the First Party to bear the financial aspects, if any after mutually agreed upon after obtaining approval from the Governing Body of the Institution for the training programs mentioned in MOU.

CLAUSE 3: INTELLECTUAL PROPERTY

Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property including but not limited to.

CLAUSE 4: VALIDITY

4.1 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

CLAUSE 5: RELATIONSHIP BETWEEN THE PARTIES

It is expressly agreed that **First Party** and **Second Party** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied. On behalf of the other Party, without the prior written consent of the other Party, Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
